

SIMPLE GLOW

Solar Lighting Made Easy

Dock Post Solar Light - Instructions/Warranty (Patent Pending)

Included: mounting hardware, rechargeable AA batteries pre-assembled, and instructions/warranty.

Mounting Instructions

Place light on dock post. With screw provided, gently tighten screw to fit the post. Do not over tighten. This may result in stripping the threads from the screw.

Replacing Batteries- **CAUTION: Failure to follow replacement procedures described below may damage the product.**

Lift the top off the light with your hands by placing your fingers under the rubber gasket on top and pulling upwards. (See Fig. 1.) For best results keep turning one inch at a time until the lid comes off. If needed, a flat-head screw driver may be used instead of your hands in the same fashion by turning an inch at a time all around the light. Careful not to rip the rubber with the screw driver as this may result in leakage into the solar panel.

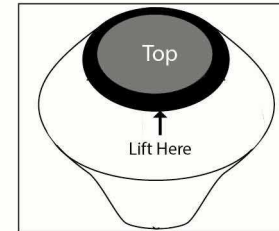


Fig. 2 (control panel)

Once the top is off, remove the plastic strip over the battery by placing the tip of a flat head screwdriver under the strip opposite the bulb and carefully lift up not to damage the light bulb. (See figure2.) This will dislodge the security strip. Replace the AA rechargeable battery.

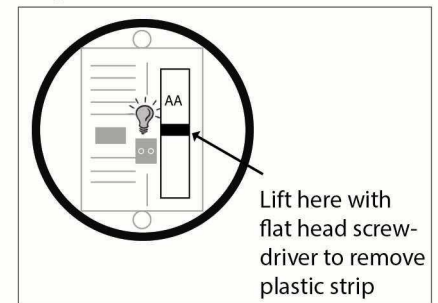


Fig. 3 (control panel)

Re-attach the plastic security strip by attaching the end opposite of the bulb first and then sliding the strip over the battery until it snaps into place. (See figure3.)

Securely replace the top. Make sure the top is snugly on for a proper seal. This will protect the control panel & batteries from the elements.

Troubleshooting: If the light doesn't work please check that the battery connection is secure. For dim lights or lights with short run times, you may need to replace the battery. The battery can be replaced with rechargeable AA batteries following the instructions above.
